The Appraisal Review Board will meet in a quorum at 3:00 PM on Thursday, July 18, 2024 to approve all panel decisions for the hearings held on July 16, 17, and 18, 2024. If no quorum is present it will be moved to the next available Thursday, for which notice will be posted at least 72 hours in advance.


1. Public Comment
