

Notice is hereby given that a public meeting of the Appraisal Review Board of the Midland Central Appraisal District will convene at 9:00 am on August 28, and 29, 2024. The meeting is held at the "Board Meeting Room" located at 4631 Andrews Highway, Midland, Texas.

The board will examine and equalize the appraisal records of the Chief Appraiser, and will hear and determine taxpayer and taxing unit appeals on all matters permitted by TEXAS PROPERTY TAX CODE.

The Appraisal Review Board will meet in a quorum at 3:00 PM on Thursday, August 29, 2024 to approve all panel decisions for the hearings held on August 28, and 29, 2024. If no quorum is present it will be moved to the next available Thursday, for which notice will be posted at least 72 hours in advance.

The Appraisal Review Board will be in session other days, notice for which will be duly posted, until all tax appraisals have been equalized and approved and all timely filed appeals heard and resolved.
