

The board will examine and equalize the appraisal records of the Chief Appraiser, and will hear and determine taxpayer and taxing unit appeals on all matters permitted by TEXAS PROPERTY TAX CODE.

The Appraisal Review Board will meet in a quorum at 3:00 PM on Thursday, October 17, 2024 to approve all panel decisions for the hearings held on October 15, 16, and 17, 2024. If no quorum is present it will be moved to the next available Thursday, for which notice will be posted at least 72 hours in advance.


1. Public Comment
