The Appraisal Review Board will meet in a quorum at 3:00 PM on Thursday, December 5, 2024 to approve all panel decisions for the hearings held on November 19, 2024. If no quorum is present it will be moved to the next available Thursday, for which notice will be posted at least 72 hours in advance.


1. Public Comment
