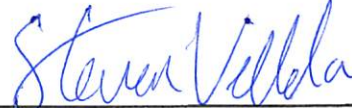


AFFIDAVIT

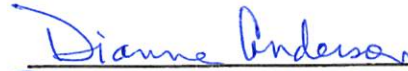

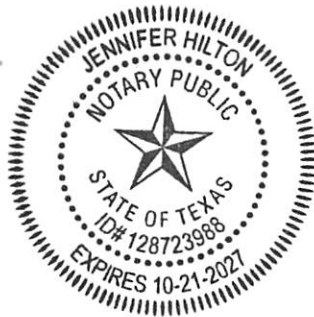
