The Appraisal Review Board will meet in a quorum at 3:00 PM on Thursday, January 2, 2025 to approve all panel decisions for the hearings held on January 2, 2025. If no quorum is present it will be moved to the next available Thursday, for which notice will be posted at least 72 hours in advance.


1. Public Comment

The Appraisal Review Board will be in session other days, notice for which will be duly posted, until all tax appraisals have been equalized and approved and all timely filed appeals heard and resolved.
