

The Appraisal Review Board will meet in a quorum at 3:00 PM on Thursday, August 17, 2023 to approve all panel decisions for the hearings held on August 7, 2023.

The Appraisal Review Board will be in session other days, notice for which will be duly posted, until all tax appraisals have been equalized and approved and all timely filed appeals heard and resolved.

Arrangements will be made for an interpreter.
