

The Appraisal Review Board will meet in a quorum at 3:00 PM on Thursday, March 28, 2024 to approve all panel decisions for the hearings held on March 27 and 28, 2024.

The Appraisal Review Board will be in session other days, notice for which will be duly posted, until all tax appraisals have been equalized and approved and all timely filed appeals heard and resolved.
