

## **EXHIBIT 2**

### **CONDITIONS OF COMMUNITY SUPERVISION FOR SEXUAL OFFENSES**

#### **SUPPLEMENT / AMENDMENT TO CONDITIONS OF COMMUNITY SUPERVISION**

Participate in and successfully complete the program(s) and/or condition(s) indicated below, pay all fees required, and continue to participate and/or fully comply until released by the Court:

1. Do not possess, own, distribute, purchase, or view any book publication, or image in any form or medium that depicts nudity of adults or children, including images which display uncovered breasts, buttocks, or genitals; including any images or videos that display simulated sexual acts; erotica; any electronic video, compact disk, computer generated material or material that is sent or received by electronic mail that is sexually oriented; and any downloads or uploads of material that are pornographic in nature.
2. Do not purchase, possess, access or view sexually explicit visual or audio material on any medium. Do not purchase, possess, access, own or operate any gaming system capable of internet access, including but not limited to Xbox consoles, PlayStation consoles, Nintendo consoles, computers that are installed with wiping or encryption software capable of preventing forensic software from accessing viewed images, text, or files that may reside on any computer device.
3. Permit the supervision officer to inspect the contents of any electronic video, compact disk, photograph, book, magazine, computer files, computer programs, electronic mail, all electronic devices that are capable of internet connection and all other property in the home of the defendant and in any vehicle owned or used by the defendant or the defendant's spouse to determine if the same contains any pornography, erotica or any sexually oriented materials in any form or medium.
4. Assume responsibility for your offense
5. Do not go on the premises of or patronize any sexually oriented establishments. Do not exchange goods for money or sexual activity. No solicitation of prostitution or sexual activity in exchange for money, goods, or services.

6. Complete all sex offender treatment evaluation requirements within ninety (90) days of referral by the supervision officer. Within ninety (90) days of completing sex offender treatment evaluation, enroll in and begin psychological counseling and treatment for sex offenders with an individual or organization as specified by or approved by the Court or the supervision officer. Attend, fully participate in, and successfully complete psychological counseling, treatment, and aftercare sessions for sex offenders. Treatment (not including aftercare) must be completed before the expiration of the first fifty (50) percent of the defendant's original term of community supervision. Pay all costs of evaluation, counseling, treatment, and aftercare.
7. Submit to polygraph examination as directed by the court or supervision officer in order to assist in facilitating sex offender treatment and to determine whether or not the defendant is in compliance with the conditions of community supervision and pay for same.
8. Register or verify registration with your local municipal or county law enforcement authority as a sex offender within seven (7) days of the date of signing of this order as required by the Sex Offender Registration Program; provide the law enforcement authority with such information requested or required; provide verification of his or her compliance to the Supervision Officer; and report all temporary or permanent changes of addresses to the local law enforcement authorities at the time and in the manner required by the Sex Offender Registration Program. The defendant should understand that failure to comply with the requirements of the Sex Offender Registration Program may result in the filing of a new felony offense(s).
9. Have no contact or visitation with any child 17 years of age or younger outside the scope of your employment unless the Court approves and authorizes the contact or visitation in advance and in writing and then only under such conditions as the Court may impose.
10. Not reside in any household with any child under the age of seventeen unless the Court approves and authorizes the residency in advance and in writing and then only under such conditions as the Court may impose.
11. Not supervise or participate in any program that includes as participants or recipients, persons who are 17 years of age or younger and that regularly provides athletic, civic, cultural or

religious activities unless the Court approves and authorizes such participation in advance in writing and then only under such conditions as the Court may impose.

12. Not go in, or reside within, a distance of 1000 feet of premises where children commonly gather, including, but not limited to, a school, day-care facility, playground, public or private youth center, public swimming pool or video arcade facility except as authorized by the Court or the Community Supervision Officer in advance in writing and only then under such conditions as the Court or Community Supervision Officer may impose. The Court or the Community Supervision Officer may impose additional restrictions regarding the defendant's residency in writing and the defendant is required to follow those restrictions.

13. Not attend any worship service or organized religious study group dedicated to individuals younger than 17 years of age. The defendant may also not serve as a counselor, leader, or mentor to any individual younger than 17 years of age without prior approval from the court and then only under such conditions as the Court may impose. This prohibition does not impact the defendant's ability to attend a place of worship for the purpose of worship services or organized religious activities.

14. Refrain from all contact and communication directly or indirectly, whether in person, by phone, by letter, by electronic means, or through a third party, with the victim of your offense and with the family of the said victim unless the Court approves and authorizes the contact in advance in writing and then only under such conditions as the Court may impose.

15. Register with the Supervision Officer all prescribed medications and confirm continued use of those medicines as directed by the Supervision Officer.

16. Do not possess, own, or operate any computer, at any location, that has access to the internet without first installing RemoteCom monitoring software. Fully participate in and comply with the rules and requirements of RemoteCom monitoring services, pay all fees required and continue to comply until released by the Court.

17. The Defendant shall comply with the requirements of the Texas Sex Offender Registration Program (*Tex. Code of Criminal Procedure Chapter 62. Sex Offender Registration Program. Art.*

62.001-Art. 62.408) The provision of those sections of the Texas Code of Criminal Procedure are incorporated by reference as if fully set forth herein.

18. Pay all of the reasonable and necessary costs incurred by the victim for psychological counseling made necessary by the offense for a period of one (1) year.

19. Pay the sum of \$5 per month each month during the period of community supervision to the Sexual Assault Program Fund in addition to all fees heretofore assessed.

20. Apply for an original or renewed Texas Driver's License or personal identification certificate not later than 30 days after release from confinement or upon receipt of written notice from the Texas Department of Public Safety (DPS). The Court further orders Defendant to annually renew the license or certificate. The DPS shall place an indication on the Defendant's driver's license or personal identification certificate that the Defendant is subject to the sex offender registration requirements. The Court orders the Clerk of the Court to send a copy of this order to the DPS and to the Defendant. Texas Code of Criminal Procedure Article 42.016.

**You are advised that under the laws of this State, the Court has determined and imposed the above terms and conditions of your community supervision and may at any time during the period of community supervision alter or modify them. The Court also has the authority, at any time during the period of community supervision; to revoke your community supervision for any violation of the conditions of your community supervision set out above.**
